REGULATION

**ON THE ASSOCIATION OF ALUMNI OF JALAL-ABAD STATE UNIVERSITY NAMED
AFTER B. OSMONOV**

1. General Provisions.

1.1. The Alumni Association of the B. Osmonov Jalal-Abad State University (hereinafter referred to as the "Association") is a voluntary association of graduates of the B. Osmonov Jalal-Abad State University (hereinafter referred to as "JASU", the "University").

1.2. The activities of the Alumni Association are carried out on the basis of the Law of the Kyrgyz Republic "On Education", the Charter of JASU, this Regulation and are guided by generally recognized international principles, norms and standards and this Regulation.

1.3. The Association is established by order of the Rector of JASU based on the decision of the Academic Council of the University under the Department of Career Development and Organization of Industrial Practice.

1.4. The location of the Association: Jalal-Abad city, 59 Rozy Azimova St.

2. Goals and Objectives of the Association.

2.1. The main goals and objectives of the Association are:

- creating favorable conditions for uniting JSU graduates for the purpose of professional unity, exchange of experience, and realization of the creative and scientific potential of the Association members;
- promoting the establishment of continuity between generations of students, faculty, and staff of the University;
- organizing meetings and communication for JASU alumni;
- creating, continuously updating, and enabling the use by Association members of a database of JASU alumni, their professional interests, and opportunities.
- assisting in the professional training of students (through round tables, conferences, evenings, practical training, internships), as well as in educational work with students, including assisting interest clubs and the development of creative teams;
- assisting in career guidance for young people, promoting student recruitment to JSU, and the employment of University graduates;
- promoting the establishment of social partnerships, and the coordination and implementation of mutual interests of business circles, local authorities, educational institutions, and public organizations with the University;
- providing assistance in strengthening the material and technical base of JASU;
- providing financial assistance to JASU graduates;

- awarding personal scholarships and encouraging talented and active students in various forms;
- communicating news and relevant information about JASU to graduates;
- conducting research aimed at studying graduate satisfaction with the education received at JASU;
- assisting in the formation and promotion of the university's brand both in Kyrgyzstan and abroad.

3. Rights and Obligations of Members

3.1. Members of the Association have the right to:

- participate in the management of the Association, the development of prospective and current work plans, to elect and be elected to the Association Council;
- receive information and methodological materials of the Association, information about the decisions of the Council and planned activities;
- provide advisory and other assistance for the implementation of the Association's work.

3.2. Members of the Association are obliged to:

- actively participate in solving the tasks facing the Association;
- participate in events held by the decision of the Association Council;
- promptly notify the leadership of the Association of changes in their home address, telephone number, place of work, and position;
- provide all possible assistance in the work of the Association.

3.3. The President of the Association:

- in conjunction with the department, develops prospective and annual work plans for the Association;
- in conjunction with the departments and the department, organizes the work of the Association: clarifies the personal data of graduates, and establishes feedback;
- creates digital platforms for more effective interaction with University alumni;
- replenishes the ranks of graduates together with the departments and the department;
- organizes events in accordance with paragraph 2.1.;
- in conjunction with the department, creates an Alumni Council from members of the Association.

4. Structure and Management.

4.1. The overall management of the Association's activities is carried out by the Alumni Council of JASU, the composition of which is formed from representatives of graduates from each year.

4.2. Direct management of the Council's activities is carried out by the President, elected by a simple majority vote for a term of 1 year from the total number of Council members by open ballot.

4.3. Control and monitoring of the Association's activities is carried out by the Department of Career Development and Organization of Industrial Practice.

4.4. Admission to membership of the Council is made at the general meeting of graduates on the basis of their personal application.

5. Membership in the Association.

5.1. JSU graduates of any year of graduation, as well as JASU employees, can be members of the Association.

5.2. Admission to the Association is carried out on the basis of a personal application (Appendix 1).
