# REGULATION

ON THE PRESCHOOL EDUCATIONAL ORGANIZATION OF JALAL-ABAD STATE UNIVERSITY NAMED AFTER B. OSMONOV

# REGULATIONS on the Preschool Educational Organization

# 1. General Provisions

#### 1.1.

The Preschool Educational Organization (hereinafter referred to as PEO or PEO of JASU) is a structural subdivision of Jalal-Abad State University named after B. Osmonov, established on the basis of the decision of the Academic Council of JASU (Minutes No. 4 dated December 13, 2023) and the Rector's Order No. 251 dated December 19, 2023.

### 1.2.

The PEO is located in the city of Jalal-Abad, at 12 Vokzalnaya Street.

# 1.3.

The founder of the PEO is Jalal-Abad State University named after B. Osmonov.

# 1.4.

The PEO of JASU carries out its educational, legal, and economic activities in accordance with the laws of the Kyrgyz Republic "On Education", "On Preschool Education", the State Educational Standard of the Kyrgyz Republic "Preschool Education and Child Care" approved by the Government of the Kyrgyz Republic (hereinafter referred to as the State Standard), as well as other normative legal acts of the Kyrgyz Republic, local acts of JASU, the Charter of JASU, and these Regulations, developed on the basis of the Model Regulations on Preschool Educational Organizations approved by the Resolution of the Government of the Kyrgyz Republic No. 765 dated November 2, 2012.

## 1.5.

The purpose of the Preschool Educational Organization (PEO) of JASU named after B. Osmonov is the comprehensive development of the child's personality, taking into account their physical, social, and emotional growth, as well as individual abilities and potential, ensuring equal starting opportunities for children when entering the first grade.

The objectives of the PEO of JASU are:

- to create conditions for every child to receive quality preschool education;
- to develop children's attention, memory, thinking, perception of the surrounding world, and speech, and to form basic mathematical concepts;
- to foster children's interest in physical education through the development of physical qualities (speed, strength, flexibility, endurance, and coordination) and the enrichment of motor experience (mastery of basic movements);
- to assist families in child upbringing as guaranteed by the state;
- to cultivate in children a humane attitude toward themselves and the surrounding world, and to develop humane relationships with others;
- to cooperate with families to ensure the holistic development of children and to enhance parents' psychological and pedagogical awareness;
- to foster citizenship, national identity, patriotism, moral, aesthetic, and environmental culture;
- to ensure continuity between preschool education and the first stage of general secondary education;

• to develop teachers' professional competence in understanding and applying new regulatory and legal documents of the Kyrgyz Republic on preschool education.

# 1.6.

The content of preschool education and child care is aimed at the cognitive and intellectual development of the child; emotional well-being; familiarization with universal human values, national customs and traditions; social adaptation; implementation of correctional and pedagogical work with children with special needs (limited health capabilities); and preparation for school.

# 1.7.

The content of education in the PEO of JASU is determined by the State Educational Standard, as well as by state, variable, and author-developed educational programs based on it.

# 2. Content of the Educational Process

### 2.1.

The Preschool Educational Organization of JASU provides for both structured lessons as a specially organized form of learning, and play-based and creative activities, ensuring an optimal balance between individual and group activities of children.

### 2.2.

The educational process at the PEO is regulated by the annual plan, calendar-thematic plans, and class schedules.

#### 2.3.

Teaching and upbringing in the PEO are conducted in the state and official languages — Kyrgyz and Russian.

# 2.4.

The PEO of JASU is independent in selecting the forms, means, and methods of teaching and upbringing within the framework defined by the laws of the Kyrgyz Republic "On Education", "On Preschool Education", the State Educational Standard, and other normative legal acts of the Kyrgyz Republic.

#### 2.5.

The content of preschool education is determined by the program(s), including author-developed programs, designed in accordance with the State Educational Standard.

#### 2.6.

The PEO organizes work in priority areas of child development that go beyond the requirements of the State Educational Standard.

# 3. Procedure for Managing the Activities of the Preschool Educational Organization

#### 3.1.

The management of the Preschool Educational Organization (PEO) of JASU is carried out in accordance with the legislation of the Kyrgyz Republic, based on the principles of democracy, transparency, and professionalism.

### 3.2.

The direct management and administration of the PEO are carried out by the Head (Director).

# 4. Duties and Responsibilities of the Preschool Educational Organization of JASU

# 4.1.

The Preschool Educational Organization (PEO) of JASU bears responsibility, in accordance with the legislation of the Kyrgyz Republic, for the following:

- violation of the rights and lawful interests of children;
- failure to comply with the State Educational Standards;
- failure to fulfill the functions established by normative legal acts;
- failure to ensure the quality and scope of educational program implementation;
- use of organizational forms, methods, and means of the educational process that do not correspond to the age, psychological, and physiological characteristics, inclinations, abilities, interests, and needs of children;
- the life and health of children and staff while they are within the PEO premises.

# 4.2.

The duties of the Preschool Educational Organization include the following:

- ensuring that the quality of preschool education meets the requirements of the State Standard of Preschool Education;
- meeting children's needs for preschool education;
- creating safe conditions for upbringing, education, and development of children in accordance with sanitary and hygienic requirements, and ensuring compliance with these standards;
- fostering in children hygienic skills, the foundations of a healthy lifestyle, and norms of safe behavior;
- apromoting and strengthening children's health;
- providing proper care for children:
- providing children with nutrition that corresponds to their age and physiological dietary norms;
- maintaining interaction with parents (legal representatives);
- disseminating among parents psychological and pedagogical knowledge about the developmental characteristics of preschool-age children;
- forming groups of children in accordance with the State Standard of Preschool Education;
- maintaining financial discipline and preserving the material and technical resources of the organization.

## 4.3.

The procedure for monitoring and controlling the activities and outcomes of preschool education is determined by the State Standard of Preschool Education.

# 5. Financial and Economic Activities of the Preschool Educational Organization of JASU

#### 5.1.

The financing of the Preschool Educational Organization (PEO) is carried out based on the funding standards of JASU.

#### 5.2.

The PEO has the right to provide additional paid educational (beyond the standard) and health-improving services that are not prohibited by the legislation of the Kyrgyz Republic.

# 5.3.

The PEO bears responsibility for the preservation and efficient use of the property assigned to it

# 6. Reorganization and Liquidation of the Preschool Educational Organization of JASU

# 6.1.

The reorganization and liquidation of the preschool educational organization are generally carried out at the end of the academic year.

The founder assumes responsibility for transferring children to other preschool educational organizations in agreement with their parents (legal representatives).

# 6.2.

In the event of liquidation, monetary funds and other property remain the possession of Jalal-Abac State University named after B. Osmonov.

# 6.3.

The reorganization and liquidation of the Preschool Educational Organization of JASU are carried out in accordance with the legislation of the Kyrgyz Republic.
