- 10. For admission to JASU, before signing the contract, the foreign citizen must submit the following documents:
- Application (to be filled in at the receiving Commission);
- completed questionnaire for foreign citizens (To be filled in MO);
- Original passport with curriculum visa and/or registration.
- 2 copies of passport
- 2 copies of visa/registration;
- 7 photos in size 3x4;
- a document on education (certificate/diploma/certificate) and a notarized translation of the document by a notary of the Kyrgyz Republic or the Kyrgyz consulate (if the document is in a foreign language), the items studied and the assessments received;
- Certificate on confirmation of education level by the Ministry of Education and Science of the Kyrgyz Republic (citizens of foreign countries);
- Medical certificates, indicating the absence of medical contraindications for study in the Kyrgyz Republic: form no. 086

- and HIV/AIDS certificate (citizens from countries entering visa regime with the Kyrgyz Republic);
- The Document on passing the preparatory course for foreign citizens entering the specialization of education in Russian.

MEMO

for foreign citizens and stateless persons

Legal position

- 1. In the Kyrgyz Republic, foreign citizens and stateless persons enjoy rights and perform duties on an equal basis with citizens of the Kyrgyz Republic, except in cases established by law or in accordance with the procedure established by law by virtue of an international treaty to which the Kyrgyz Republic is a party.
- 2. As well as citizens of the KR, foreign students have the right to rest, health protection, property and personal non-property rights, the right to education, the right to use cultural achievements, the right to freedom of conscience, the protection of their own rights and other rights, as well as the

same duties and responsibilities, Citizens of the KR.

3. Duties of foreign citizens in the territory of the Kyrgyz Republic

Foreign citizens arriving in the Kyrgyz Republic for more than five calendar days must register at the place of temporary residence in the passport tables of the Kyrgyz Republic. Registration is required: Presence of the property owner with application for registration of a foreign citizen; foreign citizen with a foreign passport with a mark on the date of border crossing of KR or ID and a travel ticket (air, railway, bus, mini bus); filled in on-site forms; payment for forms + state duty + banking services. Registration has validity period: At visa regime - for visa period, at visa-free - not more than 6 months.

- 4. In case of loss of a passport by a foreign citizen during stay in the Kyrgyz Republic, it is necessary to apply to the nearest police station for a certificate about loss of a passport, and then to address to the embassy or consulate of the country.
- 5. The first issue of all categories of visas for entry into the Kyrgyz Republic is made in diplomatic and consular institutions of the Kyrgyz Republic abroad. In order to obtain a visa, it is necessary to submit a valid foreign passport or a replacement document, a written application of the university, certified by the Ministry of Education and Science of the

Kyrgyz Republic, a visa application in three copies with photographs.

- 6. For violation of passport and visa regime of the Kyrgyz Republic and temporary registration, foreign citizen and stateless person is imposed a fine in the amount of 10,000 soms.
- 7. The exercise of the rights and freedoms granted in KR to foreign citizens is inseparable from the fulfillment of their duties established by the legislation of the Kyrgyz Republic.

Foreign citizens in the Kyrgyz Republic are obliged to observe the Constitution of the Kyrgyz Republic and its Laws, respect traditions and customs of the people of Kyrgyzstan, observe the rules of the university.

Foreign nationals, Those who have committed administrative or other offenses and crimes in the territory of the KR are subject to

Citizens of the Kyrgyz Republic.

8. What documents do you need to keep with you in Kyrgyzstan?

The main document certifying the legality of the stay of a foreign student is the visa stamp in the passport / registration. It is the passport that the police have the right to demand for identification and verification of the legality of stay in the territory of the Kyrgyz Republic.

9. When submitting documents for admission to study, a foreign citizen or stateless person indicates in the application for admission to study the requisites of the document certifying the identity or the document certifying the identity of a foreign citizen in the Kyrgyz Republic, with the translation into Russian or Kyrgyz languages, certified in the established procedure. All translations into Russian or Kyrgyz must be made on the first and last name specified in the entry visa (for the countries entering the visa regime) or in the document (passport, certificate), according to which the incoming person entered the Kyrgyz Republic.
